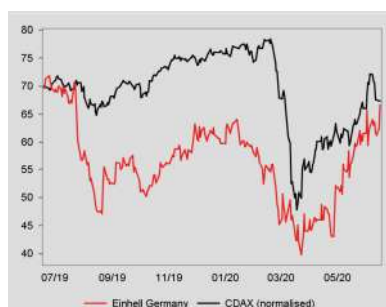
Improved FY 2020 outlook after strong sales recovery in May

Ahead of its AGM on Friday, June 19, Einhell released an update on current business development:

- Sales after five months of the year are at the previous year's level of EUR 273m (after a sales decline of 1.5% in Q1). The sales performance in May was positive across almost all major markets. The strong sales recovery in May was able to compensate for the significant sales losses in March and April caused by the coronavirus pandemic.
- Based on the very positive business trend in recent weeks, the management does not rule out that the "pre-corona" guidance (released on March 9) could still be achieved in the current year. This is assuming that there is no so-called "second wave" of the pandemic or additional regulatory restrictions in relevant markets.
- The pre-corona outlook for 2020 sales of EUR 610m and an EBT margin of around 5.5% was withdrawn on April 7 in light of the significant business deterioration at the end of March with temporary store closures by Einhell's customers in several countries. Since mid-April the situation has improved with strong catch-up sales in the DIY and gardening categories after the reopening of stationary stores.

Overall, the current business trend in Q2 is clearly better than feared owing to the shutdown across many countries and segments (our previous scenario was based on the assumption of a 22% sales drop in Q2 and flat sales in H2). Therefore, we have increased our sales and earnings estimates for the current year. Moreover, the strong sales recovery underpins the high demand in the DIY categories in the current environment and also Einhell's good strategic position in core regions, especially with the Power-X-Change series. Our mid- to long-term scenario remains unchanged. Following our revised estimates, we increase the DCF-based PT to EUR 87 (from EUR 81). **We confirm our Buy recommendation.**

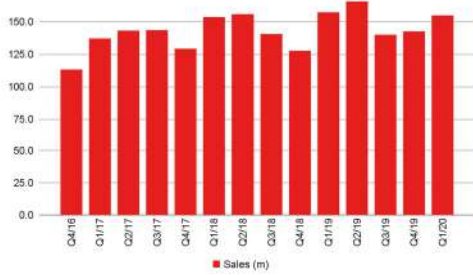

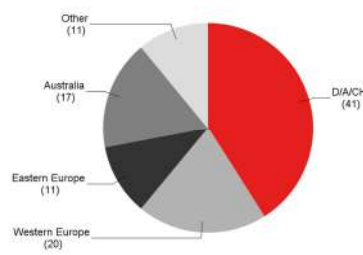

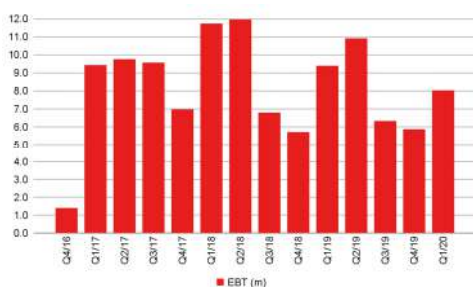
Company Background

- Einhell is the leading provider of power tools and garden equipment for household use. The products are sold under the Einhell brand and as retailers' own brands.
- Value is created in the product development, quality control, sales, and after-sales services. Production is outsourced to China.
- Einhell's main customers are large DIY chains (54% of sales), specialised trade (15%) and e-commerce platforms (14%). The share of business with discounters is at 14%.
- The company was founded in 1964 by Josef Thannhuber. The Thannhuber family holds the majority of the non-listed ordinary shares.

Competitive Quality

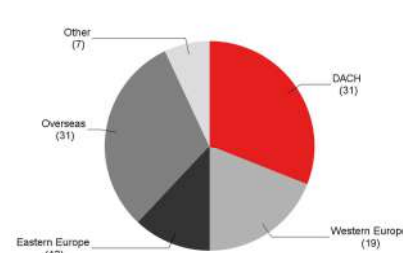
- Einhell successfully differentiates itself from its competitors by undercutting brand products such as Bosch or Black&Decker in price at a comparable quality level.

in EUR m



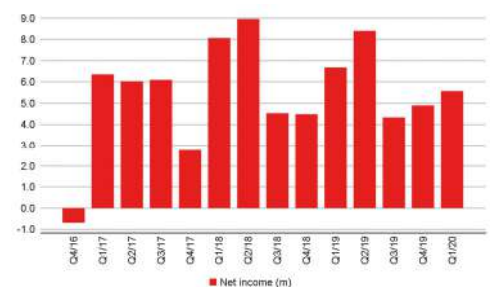

Free Cash Flow Value Potential

Warburg Research's valuation tool "FCF Value Potential" reflects the ability of the company to generate sustainable free cash flows. It is based on the "FCF potential" - a FCF "ex growth" figure - which assumes unchanged working capital and pure maintenance capex. A value indication is derived via the perpetuity of a given year's "FCF potential" with consideration of the weighted costs of capital. The fluctuating value indications over time add a timing element to the DCF model (our preferred valuation tool).

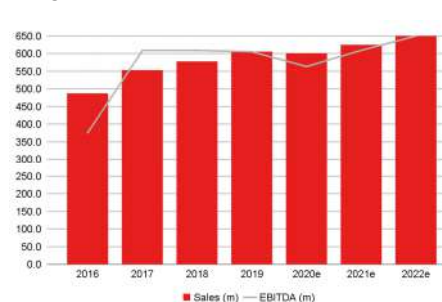

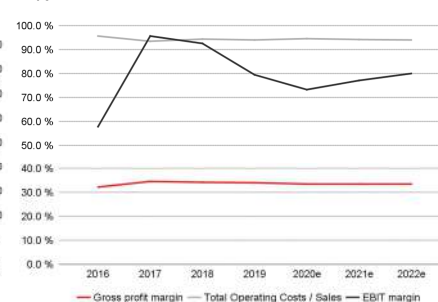

in EUR m



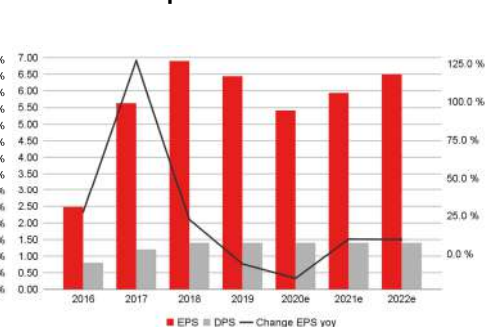

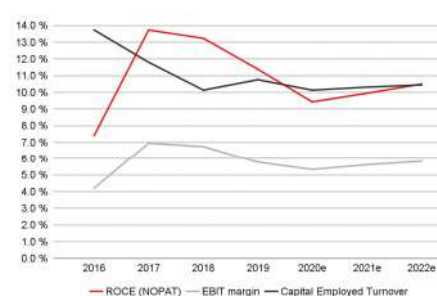

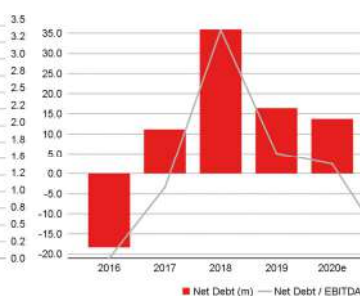

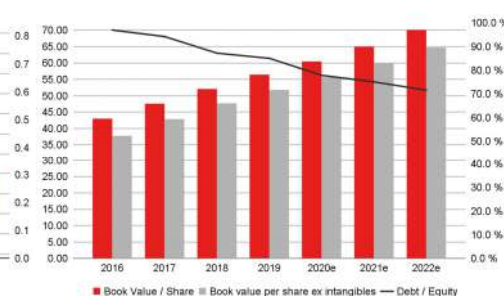
ROCE Development

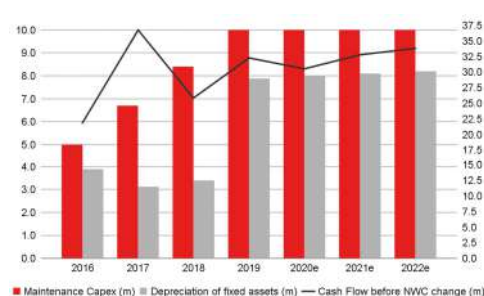

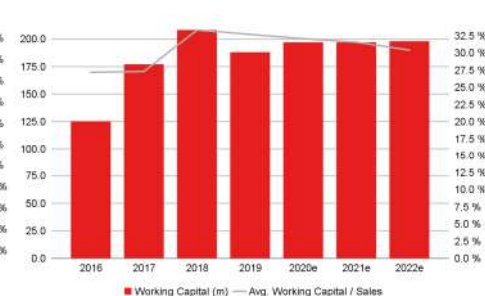
Free Cash Flow Generation
